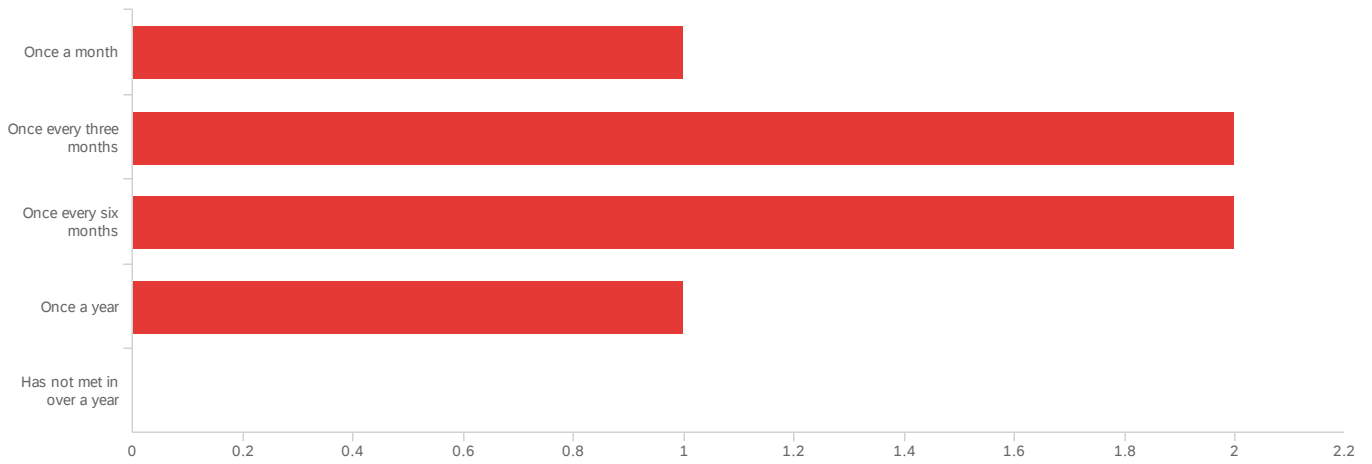

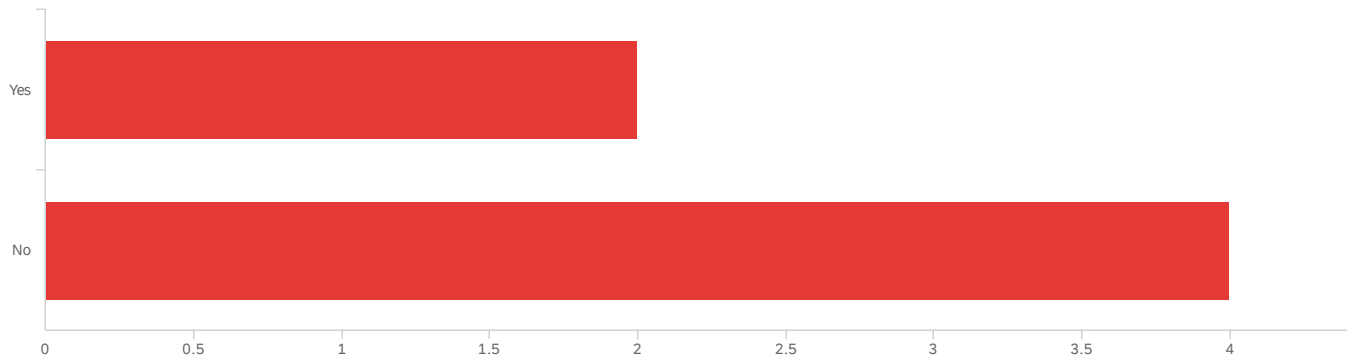

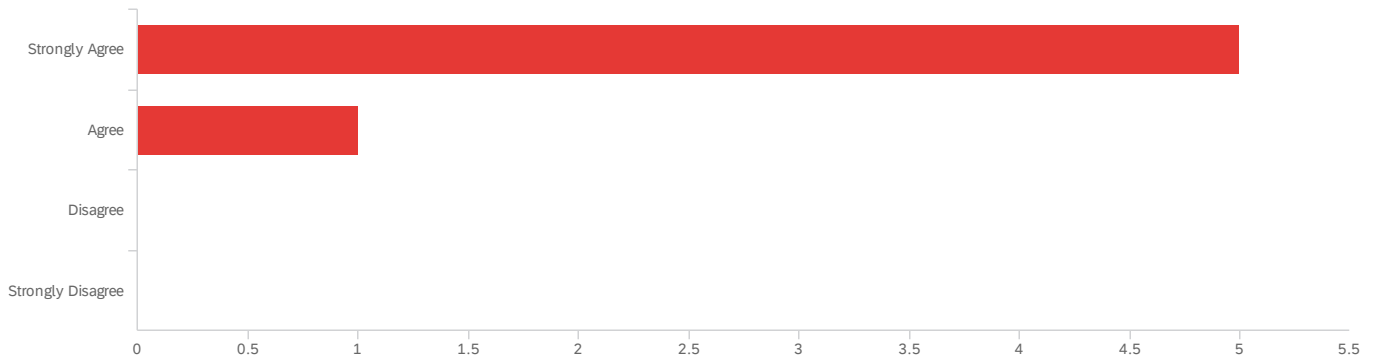

### Q3 - The committee's charge is clear and relevant.

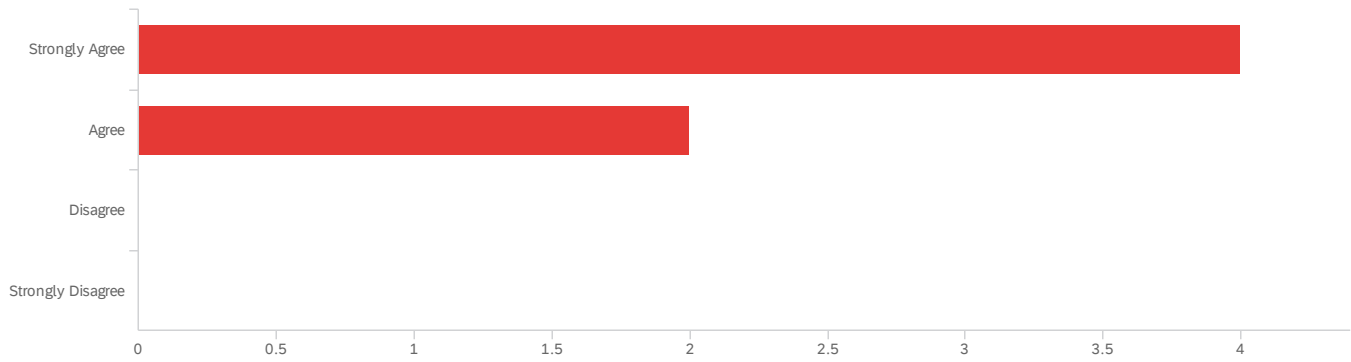

## Q9 - The members of the committee represent the correct constituents.

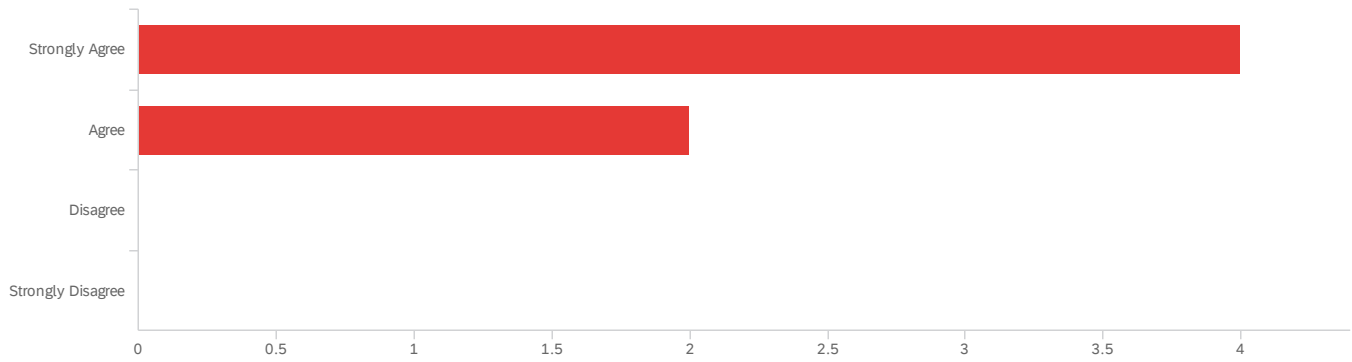

## Q10 - Meeting agendas are followed.

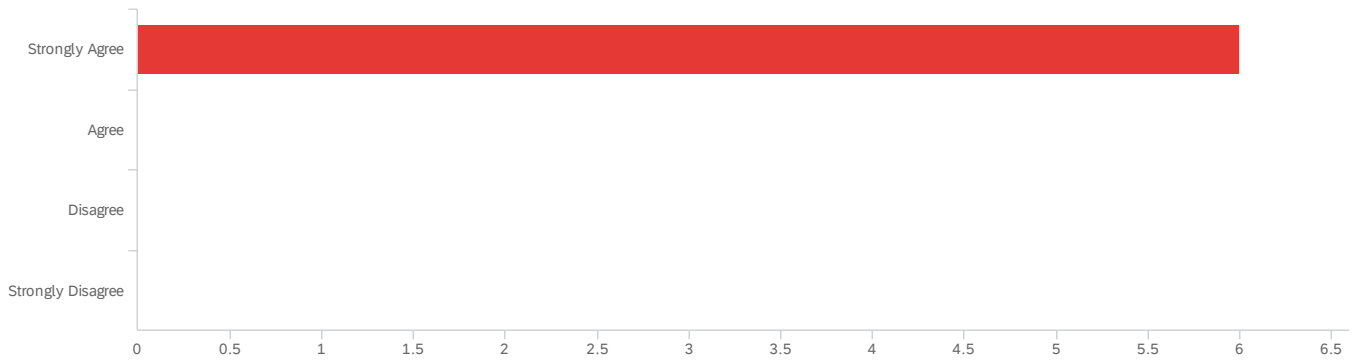

## Q4 - The committee is effectively fulfilling its charge.

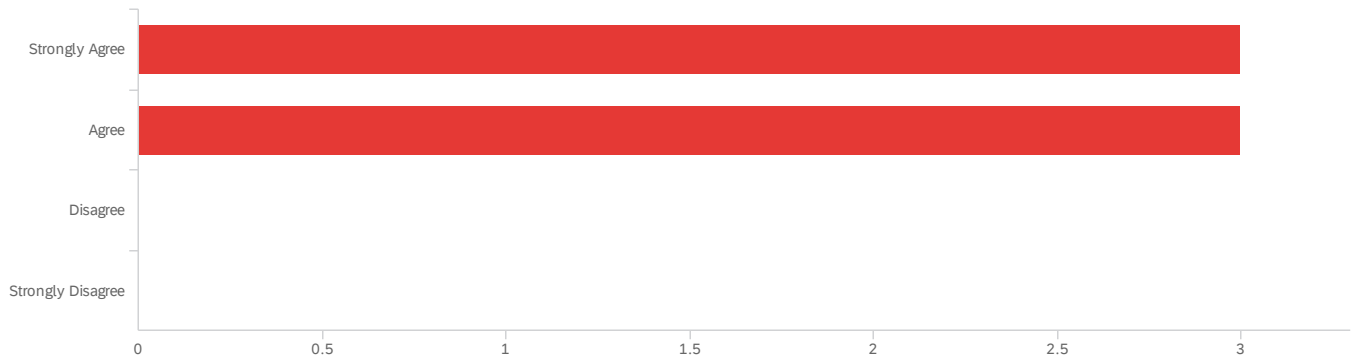

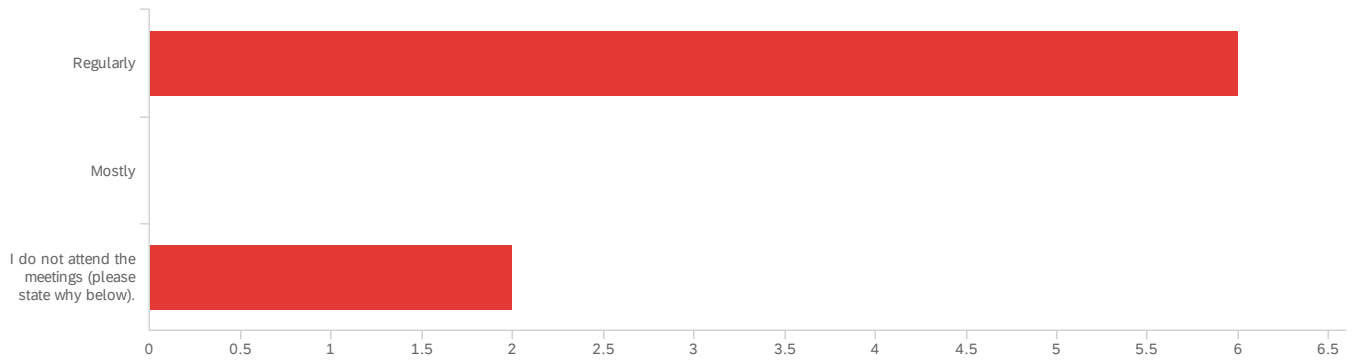
Panels meets as needed, not regularly scheduled, which is appropriate.

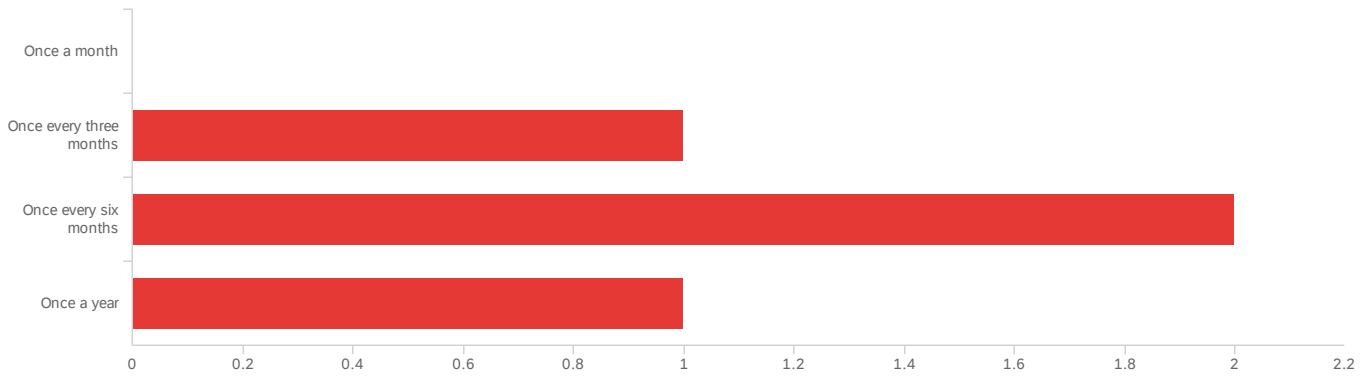

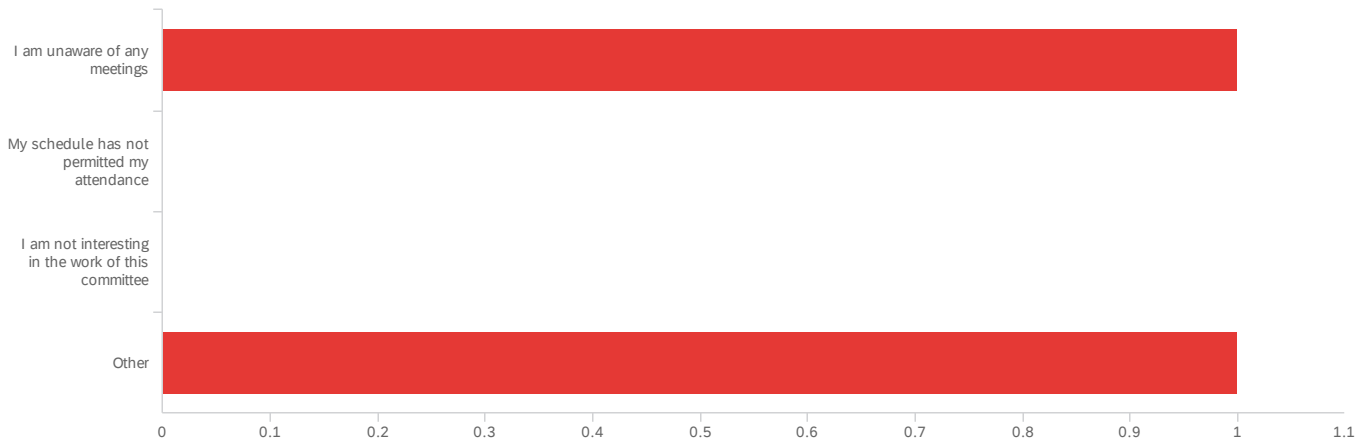
